 SIPL would try to provide a reliable service to its customers. But it would own no responsibility in case of interruptions in the network beyond its reasonable control.
- SIPL will make its best endeavors to upgrade network capacity to provide desired speed of connections to the subscribers. However the subscriber understands and acknowledges that he/she will be able to connect and operate at such speed as determined by network resources available at that time.
- The subscriber of SIPL Internet Services is not allowed to resell the Internet Services.
- The subscriber is required to use Telecom Engineering Center (TEC), New Delhi approved Interface Equipment for accessing Speed-Air Services.
